
# **Directions to the Holiday Inn Express**

The street-level entrance on Ferensway is under a canopy between "Superdry" clothes shop and the Albemarle Music Centre & Hull Truck. There is a lift to the 1st floor reception and the meeting room is also on the 1<sup>st</sup> floor. Unlimited tea and coffee will be available from the lobby next to the bar area.

If you are arriving by car, we recommend the St Stephen's multi-storey car park (not to be confused with Tesco car park!), flat rate charge £1 for any length of time after 6.p.m. There is a door from the car park into the 1st floor of the Holiday Inn Express.

The committee normally meets at 7.30 p.m. at Ye Olde White Harte, Silver Street, on the first Tuesday of each month, though the date has sometimes been changed, if necessary to accommodate new committee members' prior commitments.

### Old Town

At the listed Minerva Hotel, Nelson St, there was an application in w/c 22/1 to replace the two 1930s ground floor front windows with new timber-framed windows to match those on the upper floors and return the windows to their original 1829 appearance. (Planning ref 24/00044/FULL & 24/00045/LBC)
High St to Market Place (pedestrian

route): work is still in progress on the regraded slope beside the approach to Myton Bridge (Observed 30/1).

- Permission was granted in w/c 29/1 at 61 Market Place (above and surrounding the entrance to Hepworth's Arcade) for a revised scheme to convert the upper floors into 5 studio apartments

(Ref:23/00103/FULL).

- 9-11 Chapel Lane: replacement timberframed windows were approved in w/c

- In w/c 15/1 there was an application to erect a 2-metre-high boundary fence and gates at the rear of 9-10 Scale Lane, facing onto Liberty Lane (Ref: 23/03491/FULL).

- 1 Parliament St: approval was granted in w/c 22/1 for installation of replacement bronze plaques at the portico (Ref: 23/03473/LBC & 23/03409/ADV).

- In Zebedee's Yard, there was an application to install a figurine onto a masonry pier (Ref: 23/03526/FULL).

- Queen's Gardens, the promenade along the south side has been constructed and is being paved. Many new semi-mature trees have been planted and most of the old avenue of trees down the centre of the gardens has been felled (observed 25/1).

<u>Castle St / A63</u>: work has been in progress, with road closure at weekends, to lower the road to create a gradeseparated junction where traffic will go over the A63 from Ferensway to Commercial Road on a bridge. 2025 is the target for completion, according to Highways England on 5/2).<u>City Centre</u> - Castle Buildings is now divested of the scaffolding that has hidden it for decades, so that work can begin to bring it back into use and to re-erect the Earl de Grey in its new position facing Commercial Rd instead of facing Castle St.

- 15 South St – permission was given in w/c 29/1 for conversion of the upper floors from storage to change of use to two 2-bedroom flats (Ref: 23/02770/COU).

- 76 Paragon St. In w/c 29/1 a controversial application was submitted for change of use from vacant pub (Kingston Tavern) to "Adult Gaming

At Hammonds of Hull, permission was granted in w/c 22/1 for a roof-terrace as a "break-out space" for staff at ResQ call centre, and alterations to the entrance on West St. (Ref:23/03453/FULL)
At King Albert Chambers, 61-69 Jameson St, Listed Building Consent was sought in w/c 29/1 for external and internal alterations to Unit 1 (Ref:23/03419/LBC).

- Corner of Albion St and Bond St – an application was submitted in w/c 29/1 to build a Community Diagnostic Centre with an external space for a mobile scanner (23/03547/FULL). If approved, this would mean a significant change to the Albion Square scheme.



- Silvester House, Silvester St at the Maltings, was the subject of an application in w/c 8/1 to convert it from

offices to 11 apartments (Ref: 23/03551/FULL). - At Rhythm Room, 5 Baker St, permission was granted in w/c 22/1 for Change of Use from a night club into a Further / Higher Education facility for the TEC Partnership of East Riding College. The Rhythm Room has been empty for some time, so this is a welcome new use. (Ref:23/03475/FULL)

- 11-13 Baker St received Listed Building Consent for alterations in connection with conversion to 14 flats (Ref 21/00623/LBC).







- 6 Wright St - Approval was granted in w/c 15/1 for conversion of the ground floor office into a 2-bedroom flat (Ref: 21/00968/COU & 21/01163/LBC).

### <u>East</u>

- a revision of the approved plans for 77-79 South Bridge Rd was proposed in w/c 29/1 in an application to raise the height of the ground floor and add dormer windows (Ref: 24/00065/S73).





- At 10-12 Lime St, Allam Marine received permission in w/c 29/1 to demolish part of the street façade to create a covered yard (Ref: 23/03503/FULL).

- At 458-462 Holderness Rd, a new application was submitted to amend the approved plans to increase the 6-bedroom house in multiple occupation into 8 bedrooms and to increase parking provision to 57 car-, 44 cycle- and 4 motorcycle- spaces. 
